Under oath, I petition the court for a temporary restraining order and/or injunction against the respondent under §813.123, Wisconsin Statutes, based on the following:

1. I am:

- a. an adult at risk (an adult who has a physical or mental condition that substantially impairs his/her ability to care for his/her needs and who has experienced, is currently experiencing, or is at risk of experiencing physical abuse, emotional abuse, sexual abuse, treatment without consent, unreasonable confinement or restraint, neglect, self-neglect, or financial exploitation).
- b. an elder adult at risk (a person age 60 or older who has experienced, is currently experiencing, or is at risk of experiencing physical abuse, emotional abuse, sexual abuse, treatment without consent, unreasonable confinement or restraint, neglect, self-neglect, or financial exploitation).
- c. acting on behalf of an individual at risk, an adult-at-risk agency, or an elder-adult-at-risk agency.

- e. Cease engaging in or threatening to engage in physical abuse, emotional abuse, sexual abuse, treatment without consent, unreasonable confinement or restraint, financial exploitation, neglect, harassment, or stalking of the individual at risk, or mistreatment of an animal.
- f. Avoid the residence of the individual at risk or any other location temporarily occupied by the individual at risk, or both.
- g. Avoid contacting or causing any person other than a party's attorney or a law enforcement officer to contact the individual at risk.
- h. Other: (any other appropriate remedy not inconsistent with the remedies requested in the petition)

3. Direct the sheriff to serve and assist in executing this petition and temporary restraining order.

4. Appoint a guardian ad litem for the individual at risk. *(The court shall order and appoint a guardian ad litem if the petition was filed by a person other than the individual at risk.)*

5. Enter an injunction for four years or the following shorter period: _____
