**STIPULATION**

**IT IS STIPULATED THAT:**

1. This proceeding and any temporary orders be suspended for a period of not more than 90 days without prejudice to our legal rights.
2. Upon reconciliation, we will complete and file a **Stipulation and Order Dismissing Divorce/Legal Separation** form with the Clerk of Courts.
3. Either of us may end the suspension and proceed with the divorce by completing and filing a **Motion and Order Terminating Suspension of Proceedings to Effect Reconciliation** form with the Clerk of Courts.
4. If neither of us takes action by the end of this suspension, the action will automatically resume and the court shall proceed as though no reconciliation was attempted.
5. Warrants:
  - A.  There are **no** outstanding warrants to arrest issued in this action.
  - B.  There are outstanding warrants to arrest issued in this action.

**ORDER**

**IT IS ORDERED:**

1. All proceedings and orders are suspended.
2. The parties may resume living together as husband and wife.
3. The action is suspended for a period not to exceed 90 days from the date of this order, without prejudice to the legal rights of either party.
4. Either party may move to revoke the suspension by completing and filing a **Motion and Order Terminating the Suspension to Effect Reconciliation** with the Clerk of Court.
5. If the parties reconcile, they shall notify the Clerk of Courts in writing and have the above divorce action dismissed by the court. Dismissal of this action shall be accomplished by submitting a **Stipulation and Order Dismissing Divorce/Legal Separation**.
6. If no action is taken by either party following the end of this suspension, the action shall proceed as though no reconciliation period was attempted.
